1. Organizational Mandate and Activities

These activities include the administration and oversight of **Furqaan Project Canada**, which undertakes legitimate outreach programs and the FREE distribution of approved Islamic educational materials, including *The Clear Quran* series.

All activities of AFFC and Furqaan Project Canada are conducted under the **authority and governance of AFFC**.

2. Declaration of Non-Affiliation

AFFC hereby **formally declares and affirms** that:

- **Abdul Wahaab Saleem is not affiliated, associated, contracted, partnered, endorsed, authorized, or connected** in any manner with Al Furqaan Foundation Canada or Furqaan Project Canada.
- **Nicholas Bryan Newman (also known as Ishaan Newman) is not affiliated, associated, contracted, partnered, endorsed, authorized, or connected** in any manner with Al Furqaan Foundation Canada or Furqaan Project Canada.
- **Salik Foundation is not affiliated, associated, partnered, contracted, endorsed, authorized, or connected** in any manner with Al Furqaan Foundation Canada or Furqaan Project Canada.
- There exists **no legal, operational, financial contractual, or representative relationship** between AFFC and Salik Foundation.

Any claim, implication, or representation to the contrary is **false and expressly denied**.

Any misrepresentation following the issuance of this notice by any person **may give rise to legal remedies** available under applicable Canadian law, including but not limited to claims for misrepresentation, passing off, and interference with lawful organizational activities.
